of Fire Investigator and Fire Inspector I as required by the Office of State Fire Marshal. Lisa Watts seconded the motion. All were in favor.

4. Review letter from Appointing Authority regarding Age Requirement for Firefighter/Operator

Board Secretary Brandi Wascom provided the Board with copies of a letter from the Appointing Authority. The Appointing Authority is asking the Board to review the Age Requirement under the Qualification Requirements for Firefighter/Operator. The current Qualification Requirement states an applicant "Must not be less than twenty-one (21) years of age." The Appointing Authority is asking the Board to revise the classification plan to advise legal age of eighteen (18) only in order to be in step with all other classification plans within the department. There was a discussion regarding the effects of making this change. Gary Boudreaux made the motion to revise the age requirement to legal age of eighteen (18) for the Firefighter/Operator classification plan and post for public hearing. Lisa Watts seconded the motion and all were in favor.

5. Consider posting to abolish the classification plan of Secretary to the Fire Chief

Board Secretary Brandi Wascom submitted to the Board a letter from the Office of the State Examiner dated December 6, 2019. A review of the open classification plan of Secretary to the Fire Chief has been completed. As the department has no plans to fill this position and any other duties have been reassigned to the current Fire Records Clerk positions. Gary Boudreaux made the motion to post for public hearing to abolish the position of Secretary to the Fire Chief. Howard Ward seconded the motion. All were in favor.

6. Review revisions to the Fire Records Clerk classification plan

The Office of the State Examiner is recommending changes to the Fire Records Clerk classification plan due to the abolishing of the Secretary to the Fire Chief classification plan. The Board reviewed the changes and asked if there was any public input or objection to these changes. There was none. Gary Boudreaux made the motion to post the changes to the Fire Records Clerk classification plan for public hearing. Lisa Watts seconded the motion and all were in favor.

There being no further business before the board, Gary Boudreaux made the motion to adjourn the meeting. Howard Ward seconded the motion and all were in favor.
