A discussion was held. The Board agreed to approve the request providing Alvin Fairburn and Associates confirm with the District's Engineer (Quality Engineering & Surveying, LLC) that the additional servitude would not hinder LPFPD4's future plans for a station at that location.

BE IT RESOLVED, that the following millage is hereby levied on the 2021 tax roll on all property subject to taxation by <u>Livingston Parish Fire Protection District 4</u>:

10.00 mills

BE IT FURTHER RESOLVED that the proper administrative officials of the Parish of Livingston, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2021, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

Mr. Easley made the motion, seconded by Mr. Blevins, to accept the Resolution 21-003 and adopt the 2021 Millage Rate of 10.00 mills.
